Annual Meeting

Three important events occurred at our annual members meeting January 23.

Fred Meuer, City Manager, answered questions from the audience. He said the City is still scrambling to balance its budget after the latest blow when the State requested the return of Redevelopment Funds as a result of a recent court order allowing it to do so. Meuer said it would likely cost only one or two positions and that the City would adjust. He noted many things the City would like to do are impossible now given its fiscal conditions. He mentioned about all that can be done has been done to make retirement funding an affordable benefit, including more contributions from the employees, longer service time and scaled down plans for new employees. He said he could earn more elsewhere as could other city employees. However, the satisfaction of working for the City makes it worthwhile for them to stay on. Executive positions have been minimized making it hard to do succession planning since there are so few key positions left.

After his talk Fosler recessed the meeting for ten minutes to give the audience time to ask questions individually of Meuer, other City staff present and of the board members. The slate of candidates for the board was presented and since there were only six, the minimum needed to continue, Fosler asked for an up or down vote on the group. They were elected overwhelmingly with no no votes. Sharon Dwight then presented the projects proposed for NIP funding. Discussion of each project ensued and we voted on them. These are the ones that were selected to be presented to the NIP Committee next month.

Lighthouse Avenue

Out of town consultants made their recommendations to a joint meeting of the Planning Commission and City Council recently. The Council asked that the report be reviewed by Staff and presented to the Planning Commission quickly, after which it will be presented to Council for final approval of the proposal thus far.

We have concerns about it. It reintroduces turn lanes at Prescott Avenue, eliminating more than twenty parking places to do so. It creates three eastbound lanes above Pvt. Bolio only to have them merge there into two lanes before the tunnel. The consultants admit it does nothing to help with traffic movement. Your association wonders why we should go to the trouble and expense for so little gain. We will soon be meeting with the City to see what we can do to make positive changes that will in fact help the situation.

Airport Taxi News

If you have tried to use taxi service to get to or from MRY you know the service was inadequate and in need of attention. The Airport Board addressed the problem recently and is about to announce some changes. Yellow Cab will no longer have a monopoly on airport service.

Perhaps by April, there will be four companies providing service from which you can choose. There will be a starter at the airport to coordinate things. In addition, for the first time, the meters will be checked for calibration and the vehicles for safety. The City of Monterey will provide the administration.
